**Article 1.**

**THE CAUSE OF LOVE NATION**

Love Nation is a society which stems from the Divine Will of Spiritual Beings throughout the Cosmic Family. Love Nation is an eternal part of the ultimate unchanging reality and was created by the prime source via rays of cosmic waves emanating from the primordial waters of the Divine Mother Ki & The Father Ei through Chief KiEi Mansa from the Caldwell-Powell Clan of MANSAs.

**Article 2.**

**THE EXISTENCE OF LOVE NATION**

Love Nation is a lawfully established society of families with the sovereign authority and systems required to manage their own affairs. Love Nation hereby declares to operate as a Nation and is endowed with all rights and authorities listed herein including but not limited to such rights and authorities which any other Nation possesses. The existence and authorities of Love Nation are not subject to the formal recognition from any third party agency, or nation.

**Article 3.**

**SOVEREIGN POWERS OF THE CHIEF-MANSA**

Brahman, via The MOST HIGH ANU is the sovereign of Love Nation and all sovereign powers of Love Nation are executed via the Cosmic Constellation of Love which emanates from the Ori and the Soul of the CHIEF-MANSA of LOVE NATION. All sovereign powers of Love Nation are administered by members, Chiefs/Queens, gods, officials, and associates of Love Nation as distributed via decrees of the Chief-Mansa, the Departments, Enterprises, & Tribes of Love Nation. Powers may also be distributed via licenses issued by the Secretary of the State.

**Article 4.**

**THE PURPOSE OF LOVE NATION**

LOVE NATION is hereby established with the purpose of providing infrastructure administration services, and cosmic peacekeeping services, for the development of prosperous families and tribes.

**Article 5.****THE VISION OF LOVE NATION**

We are here to usher in the intergalactical development of cosmic societies which exist in harmony with, and in accordance with generally accepted Cosmic Laws. We see a world existing where every Spiritual Being has access to live amongst members of their own family, with enough provisions of food, water, shelter, & clothing as required. We see a world where all Tribal families throughout the Americas can live in accordance with their unique customs and traditions, yet in harmony with neighboring families and tribes.

**Article 6.****THE SCIENCE OF OUR SOCIETY**

FAITH x CVPR + GAGUT = LOVE

FAITH = Accepted Collateral pledged for the benefit of members of Love Nation.

Cosmic Value Prosperity Ratio = The percentage of stored value registered in Love Nation purposely distributed in divine timing to assure maximum benefit for members of Love Nation.

GAGUT = God Almighty's Grand Unified Theorem

LOVE = A Cosmic Bond Guaranteed by Fidelity Insurance Policy #LN999T

All policies, procedures, and laws of Love Nation must be adopted and administered according to the cosmic science of our society.

**Article 7.****DECLARATION OF COSMIC RIGHTS & INTERDEPENDENCE**

It is hereby declared that all members of LOVE NATION shall operate in accordance with Cosmic Laws; all Chiefs/Queens, officials, and special members of Love Nation shall be endowed with Cosmic Rights including but not limited to the right for their spirit to domicile within a flesh-body spacecraft free from the threat and duress, exempt from arrest, lien, and levy throughout all celestial bodies throughout the Milky Way Galaxy and beyond while operating in accordance with Cosmic Law. We further declare that we are jointly interdependent and reliant upon the existence, protection, prosperity, and well-being of each member within our Cosmic society of Spiritual Beings traveling through space within and without flesh and blood spacecrafts. All Laws,

operations, entities, and energies of LOVE NATION shall flow in accordance with the right of the Nation to peacefully exist, and the duty of the Nation to enforce its rights as required to preserve the peace and prosperity of the families and/or the existence of the Nation.

#### **Article 8.**

##### **The Supranational Society**

We are a society that consists of a collective of sovereign family and tribal governments. Collectively, the Departments and Enterprises of LOVE NATION jointly form the shared infrastructure which is to be utilized exclusively for the purpose of developing and advancing Tribal Families throughout the world.

#### **Article 9.**

##### **The Departments**

- I. Temple of Love is the established church of Love Nation.
- II. State of Love is the Estate Administrator of Love Nation.
- IV. Force of Love is the military and defense branch of Love Nation.
- V. LN FXVT Association is the Foreign Exchange & Banking Association of Love Nation.
- VI. Secretary of the State of Love is the executive administrative branch of Love Nation.
  - a. Tribal Services and Business Services of Love Nation are offered via the Secretary of the State.
- VII. ANU Bank of Brahman is the Central Bank of Love Nation.
- VIII. The Global Association of Tribal Arbitrators is the International Arbitration Association of Love Nation.
- IX. The Tribal Tribunal of Truth is the Arbitration Agency of Love Nation.
- X. The Cosmic Courts of Justice is the Supreme Court of Love Nation.

**Article 10.**  
**The Enterprises**

- I. LOVE Nation Foundation is a Gov owned International Foundation.
- II. ExpecTrust is a Gov owned Security Depository.
- III. ANU Bank is a Gov owned Bank.
- IV. LNNA is the National Numbering Agency of Love Nation.
- V. Moneyverse is a Government owned electronic money service business which issues and administers Love Nation's MNYV CBDC Tokens under the authority of ANU BANK OF BRAHMAN.
- VI. Cryptostox Moneyverse Trust is a Government owned FinTech Trust.
- VII. Association for Tribal Medicines is a Gov-owned Medicine Association.
- VIII. Executive GEMS Biz & Media is a Gov-owned Business Services Co.
- IX. Global Hip Hop Industry Trust is a Gov-owned Music Business Trust
- X. Federal Housing Relief Agency is a Gov-Owned Federal Trust Agency

**Article 11.**  
**The Registries**

**I. The Non-Swift ISIN Security Registry**

Love Nation has the right to establish and administer a Swift compatible ISIN Security Registry to be operated under the authority of ExpecTrust Security Registry, a subsidiary of ANU BANK OF BRAHMAN.

**II. The Non-Swift ISRC Registry**

Love Nation has the right to establish and administer a Swift compatible ISRC Registry to be operated under the authority of the Secretary of State.

**III. The Non-Swift ISIL, CFI, & FSN Registry**

Love Nation has the right to establish and administer a Swift compatible ISIL Registry, to be operated under the authority of ExpecTrust. The CFI number is also issued by ExpecTrust to identify the Category and Type of Financial Instrument issued. FISN codes are also issued by ExpecTrust and serve as short, standardized descriptions for financial instruments.

#### **IV. The Non-UN LOCODE Registry**

Love Nation has the right to establish and administer a U.N. compatible ILOCODE Registry, to be operated under the authority of the Secretary of State.

#### **V. The Community Vessel Registry**

Love Nation has the right to establish and administer a Community Vessel Registry in compliance with International Maritime Law, to be operated under the authority of the Secretary of State.

#### **VI. The Community Banking Registry**

Love Nation has the right to establish and administer an I.S.O. compatible **BIC & IBAN** Registry for dual usage. The Registries shall operate under the authority of ANU BANK OF BRAHMAN.

#### **VI. National ID's, & Passports**

The Secretary of State oversees the issuance of all Government Issued IDs & Passports to members of Love Nation.

#### **VII. Government Issued Documents**

The Secretary of State oversees and administers the issuance of, and online registries for all Government issued documents, licenses, & certifications.

### **Article 12.**

#### **Cosmic Law, Customary Laws, & The Great Law**

- I. Love Nation operates in accordance with the following Cosmic Laws :
  - A. GOD ALMIGHTY's GRAND UNIFIED THEOREM
  - B. The Laws of Cause and Effect
  - C. Law of Rhythm
  - D. Law of Vibration
  - E. Law of Action
  - F. Law of Polarity
  - G. Law of Attraction
  - H. Law of Gender

- I. Law of Compensation
  - J. Law of Correspondence
  - K. Law of Relativity
  - L. Law of Perpetual Transmutation of Energy
  - M. Law of Divine Oneness
- II. Our Customary Laws consist of the collection of tribal laws, oral traditions, and cultural customs currently enacted throughout our Tribal Families
- III. Love Nation honors the Great Law of LOVE as the total sum of all laws.

### **Article 13.**

#### **Triple Double Book Entry Accounting Policy**

- I. LN Accounting :  $FA's(RI+NI) + L.O.C.(P.I.) = LN Bonds = LN Bills \& Notes$ 
  - FA = Financial Assets
  - RI = Receipts and Receivables
  - NI = Negotiable Instruments
  - L.O.C. = Letters of Credit
  - P.I. = Perfected Interest
  - LN Bonds = The collective of bonds within Love Nation
  - LN Bills = The collective of Love Nation Bills of Exchange in circulation
  - LN Notes = The collective of Love Promissory Notes in circulation
- II. Love Nation Documents a total of three entries per collateral deposit transaction.
  - A. Internal (Private Tribal) Ledger :
    - i. 1 ledger entry to account for Love Nation's Security Entitlement in the relevant financial asset
  - B. External (Public International) Ledgers:
    - i. 1 ledger entry to identify the depositors Security Entitlement to an associated Bond equal to the value of the financial asset.
    - ii. 1 ledger to identify the maximum value of Love Nation Bills and/or Notes due to the depositor.



**Article 14.**  
**Security Collateral & Settlement Policies**

I. Acceptable forms of Collateral to effect the issuance of LN Bonds, Bills, & Notes :

II. Security Settlement Policy

1. LN's Integratable Intergovernmental Value System provides security settlement for International Transactions via ExpecTrust SDC&S (Security Depository, Clearing, & Settlement).
2. LN's Internal Security Settlement for all families and tribes of Love Nation is conducted via ANU Bank of Brahman.
3. ExpecTrust SDC&S has the authority and power to work with International Central Security Depositories to link and/or integrate systems in order to facilitate International Security Clearing and Settlement.
4. ANU Bank of Brahman has the authority and power to work with foreign Central Security Depositories and Central Banking Systems to establish Terminal Links and/or to facilitate International Security Clearing and Settlement.
5. ANU Bank of Brahman, the Temple of Love, and the State of Love have the power and authority to issue Global Notes up to a maximum value not to exceed the value of acceptable collateral held in trust as collateral reserves to secure the principle and/or interest due as repayment for Global Notes issued.
6. ANU Bank of Brahman, the Temple of Love, and the State of Love have the power and authority to issue NSS Global Notes up to a maximum value not to exceed the value of acceptable collateral held in trust as collateral reserves to secure the principle and/or interest due as repayment for NSS Global Notes issued.

7. ANU Bank of Brahman, the Temple of Love, and the State of Love have the power and authority to issue electronic Global Notes up to a maximum value not to exceed the value of acceptable collateral held in trust as collateral reserves to secure the principle and/or interest due as repayment for electronic Global Notes issued.

#### **Article 15.**

##### **Tribal Government Perfected Security Interests**

- I. Love Nation must secure and maintain evidence of the following series of documents from an applicant in order to perfect its security interest in collateral pledged in exchange for Government Backed Letters of Credit :
  - A. Application for Credit
  - B. Collateral Value Assessment
  - C. Security Agreement
  - D. Deposit of Security Entitlement
  - E. Lien & Financing Statement

#### **Article 16.**

##### **LN Gov Backed Letter of Credit Issuance**

Upon receipt of an application for credit and a pledge of acceptable collateral from Tribal Entities, ANU Bank of Brahman has the exclusive authority to issue government backed Letters of Credit for the benefit of the applicant. Such a Letter of Credit may not exceed the value of unsecuritized pledged qualified collateral of the applicant.

#### **Article 17.**

##### **Security Issuance, Security Entitlements, Account Deposits, & Value Transfers**

- I. All spiritual beings, members, families, tribes, trusts, and other entities of Love Nation are entitled with the contract authority required for the issuance of their own securities, and the drafting of their own negotiable instruments for the proper accounting of debts and credits.
- II. By accounting for the value of your securities and/or negotiable instruments, the issuer perfects its/his/her security interest, thereby creating a Security Entitlement.

- III. Once a security entitlement is established via underlying security being transferred in book entry form or digital form to an account of record, the underlying security and/or negotiable instrument becomes a registered Financial Asset.
- IV. Any and all Financial Assets are acceptable forms of deposits in exchange for transferable bank credits.
- V. Such bank credits shall be equal to the value of the underlying assets and may be utilized to discharge and extinguish public and private debts throughout Love Nation and Internationally.
- VI. Love Nation and all members of Love Nations have the right to utilize Tribal Banking services through ANU Bank of Brahman, the Central Bank of Love Nation. ANU Bank of Brahman may enter into agreements with foreign Central Banks, and foreign Central Security Depositories to facilitate efficient international payments by and between our members and entities and members and entities within such foreign jurisdictions. Furthermore, all Love Nation members and entities have the right to establish foreign banking relationships and obtain foreign bank/trust accounts in order to conduct international missions & family business operations.

#### **Article 18.**

##### **LN Bonds, Bills, Notes & other Negotiable Instruments**

- I. **LN Bonds** = LN Bonds are Tribal Government Guarantees for the redemption of Love Nation Bills & Love Nation Notes. Love Nation Bonds are issued by ANU Bank of Brahman.
- II. **LN Bills** = LN Bills are Tribal Government backed Orders to pay funds. LN Bills are issued by ANY Bank of Brahman.
- III. **LN Notes** = LN Notes are Tribal Government guaranteed, asset-backed Promises to pay funds.
- IV. **LN Negotiable Instruments** = LN Negotiable Instruments are negotiable Instruments, securities, bonds, bills, and notes issued by non-governmental members of Love Nation. All LN Negotiable Instruments are backed by Love Nation's Tribal Government guarantee and are acceptable forms of collateral for the exchange of Love Nation Notes.

**Article 19.**  
**Forms of Money**

Love Nation Notes and MNYV CBDC Tokens are legal tender and money in Love Nation. All Love Nation Notes & MNYV CBD Tokens are issued by the CURRENCY & CBDC Mint Department of Love Nation.

**Article 20.**  
**Presentment, Discharge, Extinguishment of Debts, Set-Offs, & Overpayments**

- I. Debts are Discharged and Extinguished upon presentment of money equal to or greater than the value of the debt due to the creditor.
- II. Setoffs are executed upon presentment of evidence to a creditor of a debt due by the creditor to the debtor, in an amount equal to or greater than the value of the current debt due to the creditor from the debtor.
- III. Compensation for overpayments are due in the event that an entity presents an amount of money to discharge and/or extinguish a debt that is greater than the amount of money due for any debt.

**Article 21.**  
**Claims & Enforcements**

- I. All claims in which all parties are members, spiritual beings, families, tribes, associations, entities, companies, persons and trusts of Love Nation must be filed in the form of a formal complaint in the Cosmic Courts of Justice. All claims with International Jurisdiction must be filed in the Tribal Tribunal of Truth.
- II. All Award Letters issued by the Tribal Tribunal of Truth, and Final Judgements issued by the Cosmic Courts of Justice hold full force and power of law and are enforceable worldwide in accordance with Cosmic Laws and/or Public International Law.

**Article 22.**  
**Adherence to Principles of LOVE, Divine Balance, & The Laws of Nations**

Love Nation as well as its members, Chefs, Queens, officers, companies, trusts, associates, and associations agree to conduct all affairs in accordance to principles of LOVE, Divine Balance, & the Law of Nations.

## **Article 23.**

### **Foreign Entity Collateral Policy**

Love Nation reserves its right to enter into collateral pledge, securities clearing and settlement agreements with any and all honorable Central Banks, and Central Security Depositories required in order to assure efficient money services exist in which to sustain International Trade, exchange, and finance.

## **Article 24.**

### **LN REAL IDs, Passports, Credit Cards, & Diplomat IDs**

#### **I. ID ( REAL I.D. Compliant)**

Members of Love Nation qualify to receive Govt-Issued IDs that are compliant with the REAL ID ACT. At a minimum, our ID's serve as documentation showing: 1) Full Legal Name; 2) Date of Birth; 3) Social Security Number; 4) Two Proofs of Address of Principal Residence; and 5) Lawful Status. Our Official Gov-Issued IDs are issued by the State of Love.

#### **II. Passport**

Members of Love Nation qualify to receive Govt-Issued Passports in compliance with the International Civil Aviation Organization's Specifications for Machine Readable Passports (MRPs) and other TD3 Size MRTDs as outlined in the Eighth Edition of the ICAO issued Machine Readable Travel Documents Manual. I further affirm that our Official Gov-Issued Passports are issued by the State of Love.

#### **III. Gov-Insured Credit Cards**

Love Nation has the power and authority to issue Gov-Insured Credit Cards fully funded by the stored value from Collateral, Security Entitlements, & Registered Credits on the Books of ANU Bank of Brahman. Credit Cards may be presented to and drawn down from any and all lawful creditors of the recipient of the credit card. Our Official Social Security Credit Cards are issued by the ANU BANK OF BRAHMAN.

#### **IV. LN Diplomat IDs issued to Agents of Global Peace**

While on this celestial body Ki, known as Earth; ALL members of Love Nation are Internationally protected persons and shall be treated as such by all Nations of the world due to exclusively operating as for the benefit of the world and properly manning their individual Vessels/Temples as agents of Cosmic Peace, Global Peace, & Infinite Prosperity.

**Article 25.**  
**Document Authentication**

All Discharge, Claim, Court, Government Issued, Business, and Enforcement Documents issued in Love Nation may be Authenticated by the Secretary of State.

**Article 26.**  
**Value System Architecture**

ANU Bank of Brahman, Anu Bank, ExpecTrust, & Moneyverse serve as the National value system architecture for the deposit, clearing, settlement, and transfer of securities and/or economic value transfers of credits and debits nationally or internationally. All systems operate in accordance with Cosmic & International Laws.

**Article 27.**  
**The Benefactors, Beneficiaries, & Trustees**

- I. Brahman, The Most High ANU, & KiEL Mansa are the Benefactors of Love Nation
- II. All Tribes, Families, and members of Love Nation are the Beneficiaries of Love Nation
- III. The Departments and Enterprises of Love Nation are the Trustees of Love Nation.

**Article 28.**  
**Chiefs & Queens**

Chiefs & Queens are the heads of Tribes and/or Families within Love Nation. As Heads of State for their respective Tribes, all Chiefs and Queens enjoy International Diplomatic Immunities.

**Article 29.**  
**Annexation of Certain International Public Treaties & Standards**

- I. Following is a list of International Public Treaties, & Standards which the Chief-MANSA of Love Nation has selected for annexation into the body of laws for Love Nation. Such laws may be utilized and incorporated in select situations in order to further and advance International cooperation, and in respect of the diversity of systems of groups and Nations throughout the world :

1. FX Global Code
  2. ISO Standards
  3. International Religious Freedom Act of 1998
  4. Convention on the Recognition and Enforcement of Foreign Arbitral Awards
  5. Convention Abolishing the Requirement of Legislation for Foreign Public Documents

  8. International Convention on Civil & Political Rights

  12. Indigenous and Tribal Peoples Convention of 1989
  13. The Outer Space Treaty
- II. Love Nation reserves its right to utilize the above laws explicitly for best use-case scenarios which allow for International cooperation and efficient systems linkage. In no way does our annexation of the above laws and/or any additional laws relinquish our sovereign right to operate in accordance with our own set of cosmic and/or customary laws.

**Article 30.**

**Full Faith & Credit Guarantee**

Love Notes are backed by the full faith and credit guarantee that Love Nation currently holds, in reserve, acceptable forms of collateral equal to or greater than the value of the Bills, and Notes in circulation at any given moment in time. Security Entitlements to the collateral held in reserve that is backing Bills and Notes in circulation are redeemable by holders of LN Notes and LN Bills upon maturity of LN Notes and LN Bills.

**Article 31.**

**Perpetual Existence of Eternal LOVE**

Love Nation has a perpetual existence and is a Nation committed to spreading LOVE.

## **Article 32.**

### **Founding Families of LOVE NATION**

The Caldwell-Powell Clan of MANSAs, Bennett Dynasty, and Odums Empire are the founding families of Love Nation.

## **Article 33.**

### **Chief-MANSA of LOVE NATION**

KiEI from the Caldwell-Powell clan of MANSAs is the first and only Chief-MANSA of Love Nation. Until the transition into a self-sustainable decentralized Cosmic Society is complete, the Chief-MANSA shall have the authority to decree any law, rule, or regulation necessary for the benefit of the Nation.

The position of Chief-MANSA exists to develop the self-sustainable systems necessary to assure adherence to the Laws of Love Nation by all departments, enterprises, entities, Families, Tribes, contractors, vendors, contracting foreigners, and all members of Love Nation. Once the self-sustainable systems of decentralized governance are fully developed, the position of Chief-MANSA shall cease to exist, and the Council of Elders shall be officially transferred the role of distribution and supervision of sovereign powers and authorities of Love Nation. The Council of Elders sovereign powers shall not be directly administered, yet are to be distributed according to consensus to the Departments, Enterprises, Officials, Members, Chiefs, & Queens of Love Nation. The role of Chairman of the Council of Elders shall always be the privy of the hereditary MANSA of the Caldwell-Powell clan of MANSAs. The role of the Chairman is to ensure that the actions of the Council of Elders are in alignment with the Laws of Love Nation and for the maximum benefit of all families and tribes of the Nation. The Chairman has the power and authority to ratify, and/or to deny orders of the Council of Elders in the event that it is found by the Cosmic Court of Justice that a proposed or current action of the Council goes against the nature and intent of the Laws of Love Nation, or is not in the best interest of the Tribes and Families of Love Nation. The Chief of the Caldwell-Powell clan of MANSAs shall serve as the Chairman of the Council of Elders. The Council of Elders shall be the supreme Authority responsible for ensuring the laws of the Constitution of Love Nation are upheld and the sovereignty of Love Nation is preserved. The Council of Elders shall consist of the Chiefs & Queens of Love Nation. The Council shall discreetly meet once every full moon to discuss issues relating to, and to vote on rulings on all issues concerning National Security, National Sovereignty, and the preservation of National prosperity.

Love Nation shall be officially established as a Sovereign Nation upon this Constitution being ratified via signature by KiEI Mansa, the Chief-MANSA of Love Nation.
